

## Application fee

From the September 2016 intake and onwards, you must pay an application fee if you are:

- a non-EU/EEA citizen not residing in Denmark and do not have a Danish Upper Secondary School Exam or a Danish higher education certificate – or
- a non-EU/EEA citizen residing in Denmark with a temporary residence permit and do not have a Danish Upper Secondary School Exam or a Danish higher education certificate

The application fee does not apply to non-EU/EEA citizens applying through an official institutional partner or for applicants graduating from one of our AP programmes when applying for a top-up bachelor programme with us.

We will not process your application, before the application fee has been paid and your application will be cancelled in case your payment does not reach us before the payment deadline.

## Procedure and deadlines for payment

We must receive the application fee before the payment deadline 15 March (for our September intake) or 15 October (for our February intake); otherwise, your application will not be processed. If you are required to pay an application fee, please follow this procedure:

### 1. FOR AP PROGRAMME APPLICANTS (September intake):

You file your application with us on [www.optagelse.dk](http://www.optagelse.dk) and forward the signature page on [apply@zibat.dk](mailto:apply@zibat.dk). You pay the required application fee of EUR 100/DKK 750 and upload a copy of the bank receipt together with your documents on [www.optagelse.dk](http://www.optagelse.dk)

### 2. FOR AP PROGRAMME APPLICANTS (February intake):

You file your application with us on our application portal: <https://efteroptag.optagelsesportal.dk/easj/>. You pay the required application fee of EUR 100/DKK 750 and submit a copy of the bank receipt together with your documents on the application portal.

### 3. FOR BACHELOR TOP-UP PROGRAMME APPLICANTS:

You file your application with us on our application portal: <https://efteroptag.optagelsesportal.dk/easj/>. You pay the required application fee of EUR 100/DKK 750 and submit a copy of the bank receipt together with your documents on the application portal.

4. If you apply without documentation for the payment of the required application fee, a reminder will be sent to you.

5. If no payment is received by the deadline, your application will be disregarded. It may take up to 10 working days from the day you make the payment until we receive the payment.
